Please continue to encourage members to take the pathway to get their SHRM certifications. SHRM provides an incentive to both the Chapters and State Council for SHRM Members who have their SHRM Certifications by the end of 2015 and 2016. In early 2016 and 2017, Chapters will receive \$20 per chapter member and State Council will receive \$10 for each person in the State who has their certification.

Treasurer – Jennifer Kinville

The Treasurer's Report and Financials were distributed for review. As previously reported, our budget reflected a \$2,000 loss for the year. The Legislative Conference has not been rescheduled yet and this could further impact the budget. Please check in with Mike and Tim before you spend money even if it is within your budget.

A suggestion was made to audit the financials. Dan agreed with the suggestion for the State Council and all of the Chapters and he further suggested that the GSHRC financials be audited prior to the merge. We all agreed this would be a good practice going forward. Dan shared that a member within the State Council or Chapter could do the audit. Tina shared that at MAHRA the President Elect does the audit. Legislative Action – Jim Reidy

Jim was unable to attend the meeting.

The Legislative Conference was originally planned for May 6, 2015 was postponed due to low attendance. Mike opened up the discussion as to how to proceed. Charla asked for ideas on the format, timing, and agenda.

Historically, it was with the GSHRC for a couple of years. It was a half day before the conference. There was low attendance the first couple of years. When the conference moved to Concord, it was changed to a full day conference where attendees went to the State House to do tours and meet with Legislators. The surveys were very positive from the attendees. Many noted that they wished they had known information provided.

The timing of the conference was scheduled to coincide with cross over (when bills move from the House to the Senate and the Senate to the House).

October may be a good time to do the conference. There may be a lot of interesting bills still in play. It was also suggested that we could partner with the NH BIA on this conference. Where we attract many HR Professionals, their focus is more on the business community and would draw in attendees that we might not be able to. The next step is to have an in person meeting with Mike, Jim, Charla, and the Chapter Legislative Chairs to discuss the substance of the conference.

Deb attended a Rapid Response business engagement where she connected with key NH players. Rapid Response is the NH Works program to assist workers dislocated due to a layoff or closing of a business.

The Workforce Innovation and Opportunity Act (WIOA), which takes effect July 1, 2015, is designed to help job seekers and workers access employment, education, training, and support services to succeed in the labor market and match employers with skilled workers they need to compete in the global economy. WIOA is having an impact on the NH Employment Security Career Centers

Featured Chapter – GMVHRA (Greater Merrimack Valley HR Association) – Kevin Kelleher GMVHRA received the Excel Gold Award from SHRM. Kevin is very excited about this!

They have planned the agenda for the next 8 months. June's meeting is on managing employee leaves followed by a break in July and August. Future meetings include September - workplace investigations with Julie Moore; October - developments in the law regarding non-competes with Mark Whitney; November - SHRM National speaker; December - workplace violence; January - employee handbooks; February - open; March - half day legal update.

There has been a lot of interest in the MA Sick Time law and how employers need to change their policies and procedures.

Kevin shared that at each meeting, they ask who has received their certifications in the past month and asks them to stand. They give them ribbons to highlight their accomplishment. Their goal is to have everyone standing.

They have 6 board members going to the SHRM National Conference and several of their members are going. Their membership is approximately 130 members and all are SHRM Members.

They have done a lot of community outreach including providing interviewing skills and job skills and also providing a scholarship to a Northern Essex student.
