Tim Dabrieo mentioned that we have the potential to hit silver this year. We are currently down 5% and a lot would need to happen this quarter for that number to shift dramatically. What has everyone done this year; additional information is still needed.

State Council donations: Discussed the difference between individual donations and what comes through the S. Mike asked is Jeannie will send the link out to everyone. Tim mentioned that last year \$4,210 and \$2,300 of that came from the SC. In order to get the Chapter Champions logo, they need more donations and we will talk more about it in December.

Kathy mentioned that SHRM is renaming its language as of 1/1/16 to "preferred provider". Kathy asked to get a list of what each chapter is doing. There are now 60,000 people certified: 34,000 of them are CP certified and 26,000 of them are SCP certified. SHRM is coming out with a lot of new tools and they seem to be much cleaner than in the past.

Social Media/Marketing - Michelle Gray

Michelle shared that she had a marketing meeting with three of the local chapters: Greater Nashua, Greater Monadnock, and MAHRA. Target marketing towards members and not just board members. All the chapters seem to be using different platforms, Michelle said it would be nice to get everyone on to one specific platform. She shared that the first round went well.

GSHRC/Conferences – Laurie Glaude/Tim Dabrieo

Strategic HR: There will be an invite to all diversity chairs to a barnstorming event. The event is in January and will focus on bullying.

ESGR Program - Dave Wheel

During the Tri-State Leadership Conference, Vermont, New Hampshire, and Maine HR State Council's signed the ESGR Statement of Support. Today, it was asked that the local Chapters do so as well. Denise Vaillancourt signed on behalf of Greater Concord, Tim Dabrieo signed on behalf of Seacoast Area, and Nancy Rowell signed on behalf of Greater Nashua. The State Council will send the outstanding Statement of Support letters to the remaining chapters: Greater Monadnock, Manchester Area, and Greater Merrimack Valley.

Dave brought two individuals with him to the board meeting. They shared more insight on what the Statement of Support means, who they are, and what they do. They are a DOD agency and they work directly with employers to show the value of supporting their local guards and reservists.

The agency has accomplished many goals. They provide education to the employer on understanding their responsibility under the law. They also provide education to the employee regarding being absent from work and re-employment when they return.

Updates: There is a unit going oversees for the first of the year. Initiatives are focused on suicide prevention. Dave will have more updates before the December meeting. Currently looking in an "ACE" program. He was thinking of bring individuals to meetings over the next 18 months to work with specialists on suicide prevention.

Barbara Hecker stated that she has dealt with suicide prevention in the workplace before and thinks this is a great idea. Maybe there is a way to send information or invite someone on a panel and get this out to chapter meetings, make people aware, and follow up.

Diversity Workforce Coalition (DWC) – Jim Whitmore

The DWC is a non-profit organization with an affiliation agreement with the State Council. The DWC began as a State Council initiative. They have three upcoming events.

The DWC is hosting an event on October 6, 2015 from 5:00 - 7:00 pm at the 100 Club in Portsmouth. The purpose of the meeting is for networking and awareness which will highlight the lack/decline of
