Legislative Action – Jim Reidy

Jim shared that one of the tracks at the GSHRC, will be a legislative track. It was a way to reboot the Legislative Conference. Breakout sessions will include Katie Marble discussing the legislative process, Dave Juvet going over the current bills going through the process, and someone will cover the rules and regulations coming along.

The October event with Kelly Ayotte was a great success! Thanks to all who attended.

The definition of a full time employee is still in the legislative process. Another interesting bill is the Gender Advancement in Pay (GAP) Act. It is based on the NH pay equity law that provides stronger protections for employees and is similar to an amendment she introduced last fall during debate on the Paycheck Fairness Act. Fees collected for violations would be used to study how the issue of pay gap can be addressed.

Workforce Readiness – David Twitchell

Dave has seen a lot of duplication of efforts between Workforce Readiness and College Relations. Dave has been working with Deb Burkholder as he transitions into this role. MAHRA merged their Workforce Readiness and College Relations roles and SHRA is moving in that direction. Dave is reviewing the two CLAs to determine if combining the two areas makes sense. Everyone is in agreement with this direction. Deb thanks Dave for taking this role on.

ACT's College and Career Readiness Campaign is looking for nominations of deserving students, high schools, community colleges, and businesses who are making positive impacts on their communities through their efforts to advance college and career readiness. Diversity – John Wilson

In November, there was a meeting to discuss how the State Council can support the efforts of the Diversity CLA and the Diversity Workforce Coalition (DWC).

John Wilson joined the State Council as the Diversity Chair on the State Council and began an initiative to start the DWC. The State Council and DWC have an affiliation and each Board has a member on the other's Board. The two organizations work together, advertise events, and support each other. The DWC discusses how they can assist the Chapters. Not all Chapters have a Diversity Chair.

Should we have the organizations merge? How can we have synergy between the State Council and DWC? Can we combine efforts to minimize the amount of duplication of efforts?

Chapters struggle with the issue of diversity. Diversity is a broad topic – more than ethnicity and race. It includes veterans, disabled, education, religion, social-economic differences, etc. The discussion centered around providing Diversity assistance throughout the State of NH. This could be a great way for the State Council to assist the Chapters and others throughout the State.

The DWC mission is broader than State Council in terms of location and efforts. Those Chapters with Diversity Chairs can help the Chapters start small – picking an area of diversity and focusing a meeting around that. We also talked about having the meeting events not be titled "Diversity".

Armando suggested doing an awareness campaign about what the DWC does and can do. We can also learn from the Chapters what they would like. Then we can work to provide the resources. These goals are in line with the State Council goals to provide resources to the community, support to chapters, and statewide programs.

We all agree to reaffirm our commitment to our affiliation with the State Council and DWC. Armando will move into the role as the Diversity Chair and will continue to be the State Council's Board Member on the DWC.

Diversity Workforce Coalition (DWC) – Jim Whitmore

SHRM Foundation - Jeannie DiBella

Jeannie is working on the report from SHRM on donations to verify that the donations are showing on the report. We encourage everyone to make a donation to the SHRM Foundation. In order to hit Platinum, the State Council would have to donate more in 2015 than we did in 2014. It does not include individual donation credits. To hit Platinum and Champion status, we would have to donate \$3,500. We have donated to SHRM Foundation this year because of the raffles at our conferences and also the donation in lieu of speaker fees for our Tri-State Leadership Conference. We decided not to make an additional donation to the SHRM Foundation in 2015.

HR Certification – Kathy Nelson
